The <u>Children with Incarcerated Parents (CIP) Initiative</u> aims to improve the quality of supports for children with incarcerated parents by using the various data and knowledge it gains to inform public policy and practice.

The CIP Initiative operates out of the <u>Institute for Municipal and Regional Policy (IMRP)</u> located at the University of Connecticut's School of Public Policy.

The CIP Initiative is Connecticut's primary resource center for information on and for children affected by familial incarceration. We serve as the state's thinktank for policy and practice recommendations involving and impacting children with incarcerated parents.

### **IMPACT**

### MADE A DIFFERENCE FOR CONNECTICUT CHILDREN AND FAMILIES IMPACTED BY INCARCERATION.

#### **Awarded**

\$13,500 in scholarships to six university students who have experienced the incarceration of a close family member. Scholars received \$1,500 each semester they were eligible to reward their academic achievements and support their goals of a degree in higher education.



#### Gifted

A \$50,000 playground to be used during social visits at York Correctional Institution for decades to come.

Providing a playground for Connecticut's only state female correctional facility is expected to realize a multitude of benefits for generations of families, and corrections personnel, for decades to come.

#### **PARTNERED**

with CT Department of Children and Families, CT Department of Correction for a 3-year federal grant offered by the Office of Juvenile Justice and Delinquency Prevention to support families. Through this collaboration, CTCIP will work together with DCF and DOC to bring awareness and educational based resources to create effective relationships with families of those affected by incarceration. CTCIP will facilitate these educational based trainings and ongoing technical assistance throughout the duration of the project.

### **ADVOCACY**

Aileen Keays, Director of CTCIP, TESTIFIED in support of legislations impacting children impacted by parental incarceration in the state.

#### RAISED H.B. 5001

TESTIFIED in support of Raised House Bill 5001, AN ACT CONCERNING CHILDREN'S MENTAL HEALTH with a request to consider including specific provisions to support children with incarcerated parents.

#### RAISED S.B. 459 & H.B. 5390

TESTIFIED in support of Senate Bill 459, AN ACT CONCERNING THE COMMISSION FOR CORRECTIONAL OVERSIGHT, THE USE OF ISOLATED CONFINEMENT, SECLUSION, RESTRAINTS, STRIP SEARCHES, SOCIAL CONTACTS FOR INCARCERATED PERSONS, TRANSPARENCY FOR CONDITIONS OF INCARCERATION AND CORRECTIONAL OFFICER TRAINING, and House Bill 5390, AN ACT REPEALING STATUTORY PROVISIONS THAT IMPOSE LIABILITY ON AN INDIVIDUAL FOR REPAYMENT OF COSTS INCURRED WHEN THE INDIVIDUAL WAS INCARCERATED.

#### FREE PHONE CALL BILL

SUPPORTED cost-free telecommunications for children and loved ones of incarcerated persons to promote child health and wellbeing, healthy parent-child relationships, assist in recidivism reduction, as well as increase public and prison safety.

# CHILDREN OF INCARCERATED PARENTS: A BILL OF RIGHTS

- I. I have the right to be kept safe and informed at the time of my parent's arrest.
- II. I have the right to be heard when decisions are made about me
- III. I have the right to be considered when decisions are made about my parent.
- IV. I have the right to be well cared for in my parent's absence.
- V. I have the right to speak with, see and touch my parent.
- VI. I have the right to support as I struggle with my parent's incarceration.
- VII. I have the right not to be judged, blamed or labeled because of my parent's incarceration.
- VIII. I have the right to a lifelong relationship with my parent.
